Who is eligible to apply for this Program?

All Whiddon Employees that hold a temporary visa (such as Working Holiday, Student, Post Graduate, etc.), have 2 or more years of experience in any of the positions listed above and have completed relevant qualifications.

This program is applicable to all Whiddon services, with the exclusion of Easton Park, Glenfield and Hornsby Community Care.

All Sponsorship Visa Holders must be willing to work on a Permanent Full Time Basis, which is a visa requirement.

Please note, if successful, you will be required to provide a current English Test (i.e. IELTS/PTE) with a minimum score of 5 or equivalent.
